Indication for Use: The Amalgatome SD System is designed to excise soft tissue in varying widths and thicknesses for skin grafting and wound debridement. It is indicated for open wounds, including wound site preparation (debridement and sharp debridement), removal of necrotic tissue and eschar, and tissue harvesting (autograft harvesting).
